Final schedules for both kitchen prep and dishwashing will be worked out on an individual basis to accommodate individual needs at camp. Laura Eliel would also like to contact each scholarship recipient to discuss existing kitchen skills you might have so that she can have a feel for what type of help she will have. Once you are approved to receive the scholarship and have been notified, your contact information will be given to the chef.
